- A.** Discuss and consider the draft 2010 Clean Air Plan Chapter 11 – Transportation, Land Use and Air Quality

Ron Tan of the APCD gave a brief history of the Land Use chapters in previous Clean Air Plans (CAP), as well as reviewed the draft chapter for the 2010 CAP. Suggestions were made to slim-down the chapter and more clearly state that it is “purely informational”. Another suggestion was made that the chapter should emphasize the jobs/housing imbalance problem in the South Coast and the magnitude of the Vehicle Miles Traveled (VMT) that imbalance produces. The sections discussing land use concepts should be de-emphasized as they would not materially reduce the jobs/housing imbalance conundrum.
