In addition, he informed members that Lee Moldaver and Michael Chiacos have been participating in the new Offsets Working Group, which is working to develop ideas to improve our Emission Reduction Credit program.

VII. New Business

- A. Receive briefing from APCD staff on the elements required to be addressed in the state Clean Air Plan triennial update, as well as the summary of components and schedule for the 2013 plan.

Brian Shafritz, Ron Tan and Joe Petrini of the APCD gave CAC members an overview of what to expect in the upcoming state Clean Air Plan (Plan) triennial update. The primary points discussed were the triennial update requirements, streamlining goals for the Plan, and initial APCD thinking on control measures. Several CAC members suggested additional discussion between the APCD and the CAC on control measures and further consideration of cost-effectiveness.
