Find that the Addendum to the 2010 Clean Air Plan Final Environmental Impact Report has been prepared in compliance with the California Environmental Quality Act and that the Addendum was reviewed and considered by this Board along with the 2010 Clean Air Plan Final Environmental Impact Report (Attachment 2) prior to approving the 2013 Clean Air Plan, and that the Addendum reflects the Board's independent judgment and analysis;
  - ii. Adopt the California Environmental Quality Act Findings (Attachment 3);
  - iii. Find that the transportation control measures approved by the Association of Governments as part of the RTP/SCS meet the emission reduction objectives established by the District for the attainment and maintenance of the state ozone standard;
  - iv. Adopt the 2013 Clean Air Plan as submitted (Attachment 4); and
  - v. Authorize the Chair to sign the attached letter (Attachment 5) transmitting the 2013 Clean Air Plan to the California Air Resources Board.
