SUBJECT: Community Advisory Council Update

DATE: February 27, 2019

The last meeting of the Community Advisory Council (CAC) occurred on November 7, 2018. As per the CAC by-laws, if there are no planning or rulemaking matters to discuss, District staff provides a quarterly update to the CAC.

The following items are provided as a status update for the period of November 8, 2018 to February 27, 2019:

Welcoming new CAC Members

Over time, and especially with changes to the District Board, the CAC membership changes. Please see attached CAC roster for the current membership. I look forward to meeting you all at our next scheduled meeting.

Board adoption of BARCT Rule Development Schedule

At the November 7, 2018 CAC meeting, the CAC discussed and recommended Board adoption of staff's proposed Assembly Bill (AB) 617 Best Available Retrofit Control Technology (BARCT) schedule, with minor changes to the project title and to the schedule itself. District staff made the recommended changes to the schedule and proposed the AB 617 BARCT Rule Development Schedule for consideration at the December 20, 2018 Board meeting, where it was approved unanimously. Upcoming Public Workshop - Revisions to District Rules 361 and 342

The District's 2016 Ozone Plan and the recently-adopted BARCT Rule Development Schedule include commitments to revise Rules 361 and 342 to reduce oxides of nitrogen (NOx) emissions

from boilers, steam generators and process heaters (units rated between 2 and 5 million Btu/hr for Rule 361, and units rated at 5 million Btu/hr and greater for Rule 342). Whereas the 2016 Ozone Plan control measures will apply only to new and modified units, the AB 617 BARCT requirements will apply to existing units at the six Santa Barbara County industrial sources subject to the state's Cap-and-Trade Regulation¹ and will require implementation by a specified date. Staff has prepared draft revisions to these rules and a public workshop is scheduled for March 14, 2019 in Solvang. After the workshop, proposed rule revisions will be brought to the CAC for discussion and consideration of whether to recommend for District Board adoption. As we get closer to a planned date, we will contact CAC members to confirm the schedule. District Board action on this item is planned for late Spring or Summer of 2019.

2018 Vessel Speed Reduction Incentive Program

Ocean-going vessels in the Santa Barbara Channel and elsewhere along the California Coast represent a very large amount of nitrogen oxide (NOx) emissions, as well as emissions of sulfur oxides, particulate matter, toxic air contaminants, and greenhouse gases. These emissions can move onshore and affect our local air quality. The District has little ability to reduce emissions from this source category since it occurs outside of our regulatory jurisdiction. However, reducing vessel speeds can greatly reduce the amount of emissions generated. The District has partnered with other local agencies to develop a voluntary Vessel Speed Reduction incentive program that incentivizes shipping companies to slow their speeds when transiting through our region. The 2018 program ended in November, and results are being finalized. For more information, see www.ourair.org/air-pollution-marine-shipping.
