SUBJECT: District Board Meeting Schedule for Year 2026

### RECOMMENDATION:

Approve the District Board of Director's regular meeting schedule for 2026.

### DISCUSSION:

District Board Resolution 12-11 specifies that the Board will meet at 1:00 p.m. on the third Thursday of the months of January, March, May, June, August, October, and December. The Board's practice has been to alternate the meeting locations between the Santa Barbara (first half of the year) and Santa Maria (second half of the year) Board of Supervisors' hearing rooms. The 2026 District Board schedule includes six meetings total, with the option to cancel the December meeting if no pressing matter needs to go before your Board. This schedule allows us to coordinate closely with that of the Santa Barbara County Association of Governments (SBCAG) Board, who shares many of the same members and are tentatively scheduled to meet on the same days.

All hearing rooms are equipped to allow remote testimony. District Board meetings are broadcast live on County of Santa Barbara Television (CSBTv channel 20) and on the web ([http://sbcounty.granicus.com/player/camera/4?publish\\_id=35&redirect=true](http://sbcounty.granicus.com/player/camera/4?publish_id=35&redirect=true)).

Due to a meeting conflict with the Board of Supervisors budget workshop schedule tentatively set for June 18, 2026, District staff is proposing to reschedule the meeting of June 18, 2026 to a Special meeting on June 25, 2026 at 1:00 pm. The District has notified SBCAG staff of the Board of Supervisors budget workshop meeting conflict and encouraged a similar reschedule to facilitate Board member accommodations. The June 25 meeting will take place at the Board of Supervisor's hearing room in Santa Maria with remote participation available in the Board of Supervisors' hearing room in Santa Barbara.

We are currently working on the audio and visual setup of the new conference room in our recently remodeled office building in Santa Maria. Once those enhancements are complete, we anticipate

transitioning the District Board of Directors meetings to that location as our Santa Maria meeting location and connecting to the Santa Barbara County Employees' Retirement System conference room as our meeting location in Goleta. We will bring this item back to the Board for consideration when the rooms are fully capable of hosting these meetings.
