SUBJECT: Discharge of Uncollectible Invoices

RECOMMENDATION:

Discharge the uncollectible invoices from Fiscal Year 2018-19 through Fiscal Year 2024-25 as listed on the attached schedule of uncollectible accounts.

DISCUSSION:

During 1997 through 2001 the District utilized the collection services of the County Treasurer for past due invoices at 60 days and over 90 days. Starting in 2002 the District began in-house collections for past due invoices at 60 days. The last time the District came to your Board to write-off uncollectible invoices was October 21, 2021.

The District's collection process is very robust and collects nearly 100% of all invoices sent to the regulated community. On average, the District sends out invoices annually that total nearly \$6 million dollars. Over the course of seven fiscal years, from 2018-19 through 2024-25, the District has accrued uncollectible invoices totaling \$23,596.91, which is less than half of a percent of the annual invoiced amount. Of the eight (8) entities with uncollectible invoices, four entities make up 88% of the total uncollectible amount (\$20,749.01) due to bankruptcies. The other entities either went out of business, decommissioned permitted equipment or cancelled permits. These fees are a mix of annual emission fees, reimbursable labor fees, source test fees, air quality planning fees, evaluation fees, diesel internal combustion engine annual review fees as well as late fees associated with these unpaid fees.

We have diligently worked to collect these amounts. The collection process is in accordance with District rules and is summarized as follows: first, all payments are due thirty (30) calendar days from the date of invoice. When invoices are over 60 days past due, a 10% penalty is assessed of the fee initially invoiced, and a letter is sent along with an updated statement to the entity. If payment is not received within 90 days of the original invoice date, an additional 20% penalty is assessed. When



payment of the invoice and penalty fees is not received within 120 days, an additional 30% penalty is assessed. The District stops issuing penalty fees at 60% of the fee initially invoiced. If payment is not received within 150 days, the District may discontinue work on the project, deny the permit application, initiate the permit suspension process, and/or initiate the permit revocation process. In addition, the District may refuse to accept an application or issue/reissue any permit until all fees and delinquent penalties are paid by the responsible entity.

Future requests for discharge of uncollectible accounts will continue to be done at the end of each fiscal year where uncollectible accounts are greater than 4 years in age or involve a bankruptcy, and total more than \$4,000.
