SUBJECT: Resolution of Appreciation for Jim Moraga

RECOMMENDATION:

Approve and present a Resolution of Appreciation to Jim Moraga for his service as an Air Quality Inspector III.

DISCUSSION:

After 19 years with the Air Pollution Control District serving as an Air Quality Inspector, Jim Moraga is retiring on March 23, 2007. During his service, Jim conducted over 1,500 inspections. The early years comprised of small business inspections like gas stations, body shops and citizen complaint response. As Jim gained more experience, the complexity of his assignments grew, reaching the most recent point where he has been the primary inspector for the majority of the oil and gas rigs in the Santa Barbara Channel for the last few years.

Prior to joining the District in 1989, Jim worked at the Santa Barbara County Public Works Department on the Route Survey crew then in the Materials Lab. Before his time with Roads, Jim worked part-time with the Treasurer-Tax Collector's office, where his wife Shirley worked for many years before moving over to Housing and Community Development.

We thank Jim for his years of service, and after more than 21 years in his career with the County of Santa Barbara, wish him well in his most deserved retirement.
